I am a Counter Fraud Investigator based at LEICESTER. I have been employed in this role for		
ten years. Part of my duties is the surveillance of those suspected of fraudulently claiming		
benefits. Four weeks ago, I received a request to carry out surveillance on a man called Alex		
GRANT who claims benefits from 33 Charles Street LEICESTER but is suspected of living at 9		
Grange Street LEICESTER. He claims Personnel Independence Payment (PIP) on the basis		
that he is unable to walk unaided for more than ten yards. The allegation stated that he takes the		
LEICESTER Bees children's rugby training at the LEICESTER Leisure Centre every Thursday		
night and occasionally referees the match at the weekend. Surveillance on// commenced at		
6 p.m. at 33 Charles Street. There was no vehicle outside and no lights on in the property. I then		
drove to 9 Grange Street where a light blue Honda Civic registration AB123 ABC with the slogan		
'In the Nick of time' pasted on the doors was parked in the drive. The lights were on in the		
property and at 6,50 p.m. a man and woman came out. The man is white approximately five feet		
ten inches, medium build, short dark hair who was later heard speaking with a local accent. He		
was wearing denim jeans and a large blue overcoat. The woman is white, approximately 5 feet		
6-inch, slim build, long dark hair and wore white framed glasses. They both got into the Honda		
Civic with the female driving and were followed to LEICESTER Leisure Centre were the male got		
out at 6.45p.m. and went inside the Leisure Centre. The female drove away. At 6.55p.m. the		
male I had seen entering the Leisure Centre at 6.45p.m. came out having changed into a black		
tracksuit with LEICESTER Bees and logo on the back. He walked to the Astro turf pitch where		
there were approximately 40 young children, both boys and girls. He had a short discussion with		
another man before taking half the children to one side of the pitch. He then began laying out		
cones before splitting the group onto teams. He demonstrated what he wanted the children to

do by running with a ball in and out of the cones over approximately 30 yards. After that exercise he demonstrated how he wanted the children to run and pass the ball by running approximately 50 yards throwing and receiving the ball with a child he had selected from the group. They then did several exercises including star jumps which he again demonstrated. The floor exercises he did not demonstrate. All this took fifty minutes. He then split the group into two teams, and he refereed a match, running up and down the pitch for one hour. The training session finished at 8.50p.m. and he went back into the Leisure Centre. At 9.05p.m the same woman driving the same car picked him up and they were followed to 9 Grange Street LEICESTER. They entered the house at 9.40p.m. Surveillance ceased at that point. I produce video footage of the training session as exhibit CFO1. My observations were from 40 yards with no obstructions other than a wire fence. It was dark but the Astro pitch had floodlights which covered the whole area.
